Impact story

Chitaram Harijan's battle with leprosy encapsulates the transformative impact of targeted healthcare initiatives in rural India. Initially burdened by debilitating lesions and financial strain, Chitaram's journey took a positive turn with intervention from the Kosagumuda Community Health Center. Diagnosed and registered as an MB case, Chitaram received comprehensive treatment under the care of dedicated Lepra staff and medical professionals. Through a regimen that included steroid therapy, his physical strength gradually returned, allowing him to reclaim his livelihood as a street vendor.



The impact of this intervention extended beyond Chitaram alone. His increased income not only stabilized his family's finances but also improved their overall quality of life. Moreover, the identification and treatment of his wife, Swati Harijan, underscored the initiative's holistic approach to combating leprosy.

Chitaram's journey stands as a testament to the transformative power of healthcare interventions in marginalized communities. Through timely diagnosis, access to medication, and supportive care, initiatives like these offer hope, dignity, and opportunity to those affected by neglected diseases like leprosy.



State Wise Updates

ANDHRA PRADESH



- SER support cheques were distributed by DLO and HOD of GGH in Vijayawada RC with the support of Mankind Pharma.
- DPMR camp at Piridi PHC served 20 patients with DPMR services and distributed footwear, attended by NLEP and PHC staff.
- MDT was provided to new leprosy cases and nutrition support was given to pregnant women in Tribal areas of Anakapalle District under Board member instructions.
- MDT adherence study was conducted in Vijayawada and Eluru RCs, involving discussions with newly treated MDT users by external evaluators.
- Wheelchairs were distributed in various operational areas in AP with the help of Oracle.
- Reorientation training programme was conducted for M.O.s UPHC and nodal officers in Krishna Dist.

BIHAR



- The National Consultation on leprosy and migration in India session was chaired by Dr. Sujay Sunitha and State Coordinator Bihar at IBIS Delhi.
- The Women-led WASH and NTD Jagruti project was implemented in Kalyanpur block of Samastipur district, and Women's Day was celebrated in all 31 gram panchayats of the block.
- A larvicide drone, using neem oil concentrate, controlled mosquitoes indoors and outdoors. Collaboration among American Leprosy Missions, LEPRAs Society, and the Indian Institute of Public Health Hyderabad covered four panchayats in the first phase of Kalyanpur block.
- On March 6th, 2024, the Civil Surgeon cum CMO inaugurated an eye clinic in Kaimur. DPM and District Health Society staff lauded LEPRAs for its comprehensive eye care services in the district.

- Twenty people attended a Disability care camp where they were provided with home-based self-care management demonstrations, self-care kits, and protective footwear.
- A Rapid Enquiry Survey (RES) was conducted at Dwarka colony Delhi where 364 people were enumerated. A survey team examined 130 individuals, and although no new cases were detected, awareness on leprosy basics was raised.

JHARKHAND



- A dissemination meeting for the Robert Luff Phase III project was held at District Health Society Dhanbad, attended by Chief guests Dr. C B Pratapan, Civil Surgeon, Dr. Manju Das, DLO, and NLEP staff. The project findings were detailed by team RC Sparsh.
- Ten individuals (6 males, 4 females) underwent Reconstructive surgery (RCS) for lagophthalmos, foot drop, and claw hand correction, followed by post-operative physiotherapy.
- A joint effort of TATA and LEPRAs resulted in the distribution of 115 bed nets at the leprosy colony Nirsra, Premnagar Baliyapur, and Nirmala Hospital Govindpur.

- The Samarth Dissemination Workshop on March 4th, 2024, united stakeholders, facilitated by Mr. Naveen Satle, offering valuable insights and culminating in gratitude for their contributions.
- Under the Sasakawa initiative, Mr. Satish Chaudhary, a seasoned expert and State NLEP Consultant, facilitated an enlightening session for 28 staff members at Oriental College, empowering them with crucial insights on leprosy diagnosis and treatment.
- Conducted training sessions for 147 RBSK medical officers, enhancing their capacity in leprosy case detection among children, bolstering the ongoing efforts to combat leprosy.

- Collaborated with Odisha Livelihood Mission Cluster Level Federation to link LF patients with livelihood activities in Nayagarh.
- Conducted an MMDP clinic at DHH Puri and held a SSG Formation Meeting at Raigorada with ASHA-3, Lep-1, and LF-11.
- Organized a Self-care Camp on Leprosy with Bijatala CHC addressing awareness, treatment, and self-care.
- Held ASHA Worker Training on Leprosy and LF at Jharadihi to enhance community engagement.
- Conducted awareness campaigns on Leprosy and LF at Gorumahisani weekly market and Bahalada using our IEC van.
- Observed Women's Day at Rairangpur and Bahalada Block in collaboration with the Health Department.

TELANGANA



- NLRC celebrated World Women's Day 2024 by honoring women stakeholders and staff in Hyderabad, with notable guests and event coverage in regional media.
- World TB Day was marked with the theme "Yes! We can End TB" in two DMCs of Hyderabad district, featuring public awareness programs over two days.
- 4th-year MBBS students from Osmania Medical College visited a leprosy clinic in Hyderabad, expressing surprise at not encountering any leprosy cases before.
- Three shoe technicians from Telangana underwent a 25-day skill development training on footwear manufacturing, receiving electronic sewing machines upon completion.
- ASHA volunteers at PHC Lonavally, Asifabad district, participated in an awareness program on Leprosy Case Detection Campaign.
- All four RCs of Telangana supported the District NLEP team during the Leprosy Case Detection Campaign, raising awareness and conducting suspect validation.

- Ms. Sirisha and Ms. Anita Rego conducted focused group interviews and in-depth interviews for MDT adherence study project in Vijayawada, Eluru, and Tiruvuru.
- Dr. Michael Sukumar Pallapati monitored Leprosy Case Detection Campaign implementation in Hanamkonda, Warangal, and Jangaon on 20 and 21 March 2024.

My journey with LEPRA began as a Laboratory Assistant at the KORALEP Project in Jeypore, Koraput, back in February 1996. Following the completion of my DMLT course, I rejoined LEPRA as a Laboratory Technician at the JUNLEP Project in Junagarh, Kalahandi, in March 2008. Over the years, I've assumed various responsibilities, eventually leading to my current role as a Field Coordinator in Kalahandi District.

What inspired your dedication to serving communities affected by Leprosy, Tuberculosis, and neglected diseases?

My inspiration stems from LEPRA's mission of providing comprehensive healthcare to marginalized communities. Working closely with these communities, particularly in remote tribal areas, has taught me the value of simplicity and resilience. Observing the challenges faced by individuals affected by these diseases reinforced my belief in the importance of serving those in need.

Could you elaborate on some of the challenges encountered while working in remote tribal areas, and how they have been addressed?

Working in remote tribal areas presents challenges such as limited access to healthcare facilities, cultural barriers, and geographical isolation. However, our team at LEPRA addresses these challenges by adopting a multidisciplinary approach.
