Additionally, three of our shoe technicians have commenced skill training at FDDI, and we are grateful for the institute's generosity in providing sewing machines for their use. Anticipating positive developments in the upcoming year.

### Impact story

Surendra Mahto, a 35-year-old resident of Village Maniyaarpur in Samastipur District, faced a daunting journey when leprosy-related afflictions disrupted his life for over three years. As a former vegetable seller in Delhi, his health took an unexpected nosedive with mysterious spots and numbness. Despite consulting numerous doctors and undergoing various treatments in Delhi, relief remained elusive, and his condition worsened.

Returning to his roots in Bihar for solace, Surendra's quest for effective treatment continued to be fruitless. A chance encounter by the roadside with a compassionate Lepra worker proved to be the turning point. Urged to visit the Kalyanpur Public Health Centre (PHC), Surendra found respite at the MMPD Clinic within. Extensive support and a thorough examination led to the prescription of



Multidrug Therapy (MDT) and steroid therapy, swiftly ending his ordeal with leprosy.

Empowered by recovery, Surendra secured a bank loan, investing in a rickshaw to rebuild his life. The Lepra Society played a pivotal role, aligning with its mission to strengthen the livelihoods of individuals like Surendra. Today, he joyfully manages his health and family, expressing profound gratitude to Lepra field staff for the transformative intervention that marked the beginning of a promising new life filled with resilience and hope.

# STATE WISE UPDATES

#### ANDHRA PRADESH

- Lepra staff, along with NGOs and NLEP members, marked World Disability Day in AP, distributing aids and submitting patient needs representations.
- Jaggaiahpeta CHC organized an HIV awareness rally on World AIDS Day, with participation from M.O., counselors, health staff, and Lepra staff, covering CHC to Rama Talkies area.
- Vakodu PHC in Vizianagaram Dist. organized a DPMR camp, with 25 patients practicing self-care methods and receiving footwear. PHC M.O., staff, and DPMOs attended the program.
- Organized a training session at Jaggaiahpeta CHC for PHC staff on wound care. The program included demonstrations and re-demonstrations on ulcer care, along with an orientation on Leprosy. M.O. and PHC staff actively participated in this educational initiative.
- Lepra AP's ongoing School Survey program, all schoolchildren are undergoing physical testing for Leprosy symptoms. The initiative includes educating them on signs and symptoms, and children are contributing funds. Tenali outreach staff actively participated in this program.
- Chowtupalli PHC organized ASHA orientation programs, enlightening ASHAs about leprosy signs and symptoms. The event saw participation from ASHAs, MLHPs, ANMs, and PHC staff.
- With the generous donation from Nataraj Jewellers, Tenali, 25 footwear items were distributed to individuals affected by Leprosy and LF at Old Govt. Hospital. The distribution was facilitated by the participation of AMO and Fillaria unit staff.

- LEPRA aids LCDC in 9 Bihar districts, detecting 2509 leprosy cases, ensuring MDT treatment.
- The ASPIRE project team has been implementing an Integrated approach of Active Case Detection for the past year, which has helped in finding 621 new leprosy cases, including 106 children (17%) and 9G2D cases (2.3%)
- Jagruti project facilitates UDID cards and pension schemes for 77 G2D leprosy cases and 553 LF-affected individuals.
- Bihar's Mobile Footwear Unit provides 2588 customized footwear.
- Sparsh Referral Centre, Dhanbad, performs reconstructive surgery for 16 individuals with TATA partnership.
- Two-day PT training at Little Flower Hospital focuses on physiotherapy basics, footwear, orthosis, self-care, counseling, and reporting.
- LEPRA collaborates in Bihar's ELF program with WHO, PCI, Piramal Swasthya, Clinton Foundation, GHS, and CFAR.
- LEPRA supplies 9200 dose poles for LF in 4 IDA districts and trains 21 MOs and 20 Block Health Managers.
- Provided 739 portable commode toilet seats and compression garments aids individuals affected by NTDs, especially those with LF, enhancing accessibility and comfort.
- World Sight Day celebrated in Bihar's Urban Eye Health Project with the theme "Love your eyes at work." The project focuses on eye care for urban poor, providing refractions and spectacles.



- A DPMR Clinic & Self-Care camp at Bakawand CHC empowered 17 disability beneficiaries in self-care. 10 received MCR footwear and dressing kits.
- a Leprosy Forum Formation meeting in Ramni village saw the participation of 15 parents and PRI members. Another Forum Formation meeting was conducted at Sirni village

## STATE WISE UPDATES



- International Disability Day was observed in the project area, featuring six distinct events organized across various districts in the state during this period.
- LEPRA TI-Koraput observed World AIDS Day at Jeypore Bus stand
- Two PMP/RMP Sensitization programs were conducted in Bargarh and Kalahandi districts, sensitizing 48 individuals on Leprosy and LF.
- Five Integrated DPMR Clinic and Self-Care camps were organized in the project area. Sixty-three individuals with cured leprosy attended, benefiting from items such as footwear, ulcer kits, and adoptive and protective devices.
- Education support checks were handed over to girl students as part of the Girl Child Education Program in the presence of the CDMO in Nabarangpur.

#### **TELANGANA**



- World Disability Day was observed at Devapally leprosy colony, Nizamabad. Two pairs of crutches, 10 hand sticks, and seven pairs of MCR footwear were distributed to the beneficiaries in need.
- An awareness program on leprosy was conducted for the women's group at Basti Dawakhana, Manikonda, Ranga Reddy District.
- Capacity-building session conducted for Rastriya Bala Swasthya Karyakram (RBSK) doctors and health staff, focusing on Leprosy and LF.
- Weekly sessions on ulcer dressing and self-care practices have commenced at Christ Delphi Rehabilitation Center in Dasarlapalli, Siddipet district.
- An awareness cum screening program was conducted for school students of Sri Vivekananda Educational Society in Hyderabad. During the program, one MB Female Child case was diagnosed.
- recently elected MLA, Dr. Palvai Harish Babu, an Orthopaedician, visited LEPRA RC in Kagaznagar.
- Dr. Sireesha Patel, WHO Zonal Coordinator for NTDs in Andhra Pradesh, Telangana, and Karnataka, visited NLRC and engaged in interactions with Gr.2 leprosy cases.
- A collaborative meeting with Dr. BRKR Ayurveda College focused on an integrated approach for managing foot ulcers in leprosy and diabetes. Meet our staff

With over 20 years of expertise, Mrs. Vijayalaxmi is a physiotherapist and now at SJLC, Sanwad, MP, where her current focus is on easing the difficulties that

leprosy patients confront.
How did you embark on your journey as a Physiotherapist, and what inspired you to pursue this path?

When I commenced my career in 1998 at HOINA in Odisha, I had no specific ambition; it was all about dedicating myself to the work. Working within a focused team left little time to reflect. However, over the years, my focus has evolved, and I am currently dedicated to working exclusively with Leprosy patients due to the persistent stigma surrounding this condition. Could you share a remarkable success story or a memorable patient interaction from your extensive career?

An inspiring story from my time in Assam involves a person with multiple deformities who was socially isolated. Facing community rejection, he sought help from the AIFO team. After undergoing two surgeries and receiving financial support, he started a small soap business. Today, he earns a monthly income of 60,000 rupees, and his once-isolated village now

relies on him for essential supplies.

What techniques or strategies do you employ to ensure patients feel comfortable and at ease during their physiotherapy sessions?

Dealing with individuals who may not be familiar with the treatment process requires effective communication. I find that being a bit friendly, speaking softly, showing kindness, and exercising patience are key elements in making patients mentally prepared and comfortable during their sessions. This approach fosters a positive and reassuring environment for their overall well-being.
